### Exciting Ongoing Projects at EMC!

- EMC is working in partnership with **Social, Environmental and Economic Solutions Ltd (SONECS)** for conducting a rigorous stakeholder engagement exercise to increase understanding of specific barriers to reducing plastic waste within the plastic packaging supply chain in India. This project has been funded by **UK Research & Innovation (UKRI)**. EMC has been engaged by **UNIDO** to conduct a global study to investigate the **impact of COVID-19 on green SMEs**, to what extent the COVID-19 pandemic has hindered SMEs business and what would be a sustainable mechanism for SMEs to recover and transform. The study will focus on India, Ghana and Uruguay. EMC has been contracted by **Packfora LLP**, to review the **Extended Producer Responsibility (EPR) Policy** that is being drafted by them for **Rwanda**. EMC will conduct the review and provide necessary suggestions and recommendations for the same.
- EMC has been appointed by **NITCO**, a ceramic wall and floor tile manufacturing company, for developing a sustainability blueprint at organizational level. The project involves conducting a situation analysis, compliance check, and top-level material and energy flow analysis. EMC will provide advice on Environment Social and Governance Management System (ESGMS), Environmental Product Declaration (EPD) and disclosures and reporting requirements.
- EMC has been appointed by **BanyanTree Finance Pvt Ltd**, a private equity fund, to conduct Environmental and Social Due Diligences (ESDD) prior to investments, post investment monitoring and conducting Impact Assessments of the Fund's Portfolio. EMC has been commissioned by a large Indian Infrastructure Fund to perform an Environmental and Social Due Diligence (ESDD) of a Fin-tech-based financial service company. EMC has been appointed by an Agri-tech, food, and rural business focused Indian venture growth equity fund, to conduct an ESDD for a Rural Distribution Platform for *Kirana* stores. EMC has been appointed by an Impact-focused investment management firm, to conduct ESDD of a company providing innovative battery recycling technology services.
- EMC continues to be engaged with **SBICAP Ventures** to conduct ESDD for investments under the SWAMIH Investment Fund and for potential investments by **Omnivore Fund II**.

### Dr. Prasad Modak delivers a talk for MBA students at SIIB


