Dr. Modak to develop Framework for the Establishment Centre(s) of Excellence on Circularity in India

Dr. Prasad Modak has been contracted by UNITAR to prepare a Framework for the Establishment Centre(s) of Excellence (CoE) on Circularity in India. The framework will suggest a business plan, suitable governance and strategies for financial sustainability for the CoE. A guidance manual for selecting the candidate host entities that would constitute the CoE will also be prepared as part of this project. It is expected that the proposed CoE on Circularity will contribute to taking forward India's intent to align future economic policies, investments more closely with SDG12 and achieve its net zero target by 2070.

Training of Railways (NR) Officials on Waste Management and Circular Economy Solutions

EMC successfully completed the Pilot Training of Railways (NR) Officials on Waste Management and Circular Economy Solutions. This project was supported under the "Circular Economy Solutions (CES) Preventing Marine Litter in Ecosystems" that is being implemented by the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH jointly with the MoEFCC. The pilot training was conducted over 3 hours in 2 batches and saw participation of more than 100 officials on each day.

Sameer Kulkarni's participation in "Circular Enterprise Replication and Incubation"

Sameer Kulkarni from EMC team recently got the opportunity to attend a three-day Circular Economy Catalyst Training of Trainers Program on "Circular Enterprise Replication and Incubation." The program was primarily for business development support advisors and management consultants to help start-ups in the circular economy. The program was designed and organized by adelphi, SEED, and supported by the IKEA Foundation.

During the program, the participants were trained on using various frameworks from the Circular Economy Toolkit developed by adelphi and SEED. The participants were divided into various groups to work on a business case and cover the stages of a startup journey (Discover - Design - Test - Refine - Demonstrate) using tools such as the Circular Economy Compass, circular economy intensifier, and Lean circular Enterprise Blueprint. The case studies were focused on creating a sustainable business model in the areas such as collection and recycling service, upcycled products, e-bike sharing rental model, and new product development.

Sameer Kulkarni is now a certified trainer on business advisory in circular economy. Ekonnnect can provide support to early-stage or ideation stage enterprises leveraging on his training.

Sakshi Gore was selected as one of the participants from India to attend the Tech Camp, that was organized by The Centre for Public Policy Research (CPPR), Kochi with the support from the U.S. Consulate General in Chennai and was held in Kochi from 19th May to 21st May 2022.

All participants were mentored by international experts on topics that would strengthen their understanding of marine challenges and identify cross-sectoral solutions for the same. The camp laid emphasis on the importance of effective technology and communication as important tools for solving environmental challenges.

Participants identified challenges and worked extensively for three days under the guidance of mentors to design and present solutions. Some of these solutions will be funded by U.S Consulate General to encourage their pilot implementation in the coming months.

Training Program on ESG in Partnership with NITIE (July 18-22, 2022)

Ekonnnect Knowledge Foundation in partnership with National Institute of Industrial Engineering (NITIE) and Environmental Management Centre LLP (EMC) successfully completed Module 5 on Biodiversity between 2-6 May 2022 as a part of Certificate Program on Sustainability. 31 participants attended this module and gave an average rating of 7.2 out of 10. White paper publications on Policy recommendation

EMC successfully completed three White Papers on policy recommendations for air pollution mitigation as part of its project commissioned by Institute for Sustainable Communities (ISC). These papers focused on three key topics-1.) Defining an airshed based approach to air quality management as part of the implementation of clean city air action plans, 2.) Identifying possible opportunities for integrating climate action into the formulation of city clean air action plans and 3.) Identifying innovative financing mechanisms and institutional models that are linked to air quality improvement and management. Stakeholder consultations were carried out in financing the White Papers.

Training of EMC Team

Rohit Pansare, an EMC Associate, conducted a two day course on Q-GIS for the EMC team to enhance their technical capabilities. The course focussed on GIS, vector processing tools, Raster processing tools and SCP Plugin. A total of 4 members of the EMC team fulfilled the requirements and received a professional certification for the same.

Sameer Kulkarni, Jaykumar Mehta and Aditya Gussain completed training for water audit (a tool for water conservation in industries) conducted by Centre for Science and Engineering and received certificates.

Conduct of Circular Economy Modules for Anant University

EMC successfully delivered the Circular Economy Module for the Anant Fellowship Program on Built Environment. This Module was delivered through a series of lectures by experts from EMC and subject experts outside of EMC. One of the key modes of engagement with the Fellows of the program was the group assignment where the teams prepared a project brief and a brochure to communicate a project idea that they developed on integrating circularity criterion in a construction project.
