This month, we celebrate the International Youth Day that seeks to highlight ways in which the engagement of young people can accelerate action towards achieving Sustainable Development Goals (SDGs) and fighting COVID-19.

#### Did you know?

The economic impact of COVID-19 is set to make the job market more challenging for youth. Young innovators are already responding to the virus through social impact innovation. Whilst most of these initiatives are on a voluntary basis (e.g. young people offering to shop for and deliver food to elders or at-risk people), they can also take the shape of social enterprises.

Many youth-driven technology innovation hubs are supporting start-ups to develop effective solutions to address COVID-19. Ekonnect in partnership with LetsEndorse Development and support from ThoughtWorks, organized a <u>social hackathon</u> where one of the challenges focused on early epidemic detection. #### Indian Railways Virtual Training Program on Environment and Sustainability

Dr. Prasad Modak was engaged by UNEP India office to develop a capacity building framework and training content in consultation with the stakeholders for Indian Railways on Environment and Sustainability. He was the Chief Mentor for delivering this pilot training program. Dr. Modak was joined by Mr. Shantanu Roy and Ms. Sivaranjani Subramanian from Environmental Management Centre LLP as co-faculties.

Under the project, a status paper on sustainability perspective in Indian Railways and a Strategic Action Plan for Capacity Building on environment was prepared. An intensive week-long training programme was developed, and 23 topics were chosen in consultation with officials from UNEP and Indian Railways. This programme included topics such as climate change, green economy, sustainable public procurement, biodiversity & conservation, waste management, water conservation, energy efficiency, green buildings and India's Intended Nationally Determined Contributions (INDC) to name a few. Course content was developed, and peer reviewed by 19 global experts from various sectors.

The pilot training programme was conducted virtually between 10-18 July 2020. 51 participants across different tiers of officials from railways participated in the programme. 10 faculties across 7 Central Training institutes (CTIs) of Indian Railways also joined the programme as future Master Trainers.

The formal inaugural session of the training program was attended by many dignitaries including Dr. C. Chandramouli, Secretary, DoPT, Shri Sanjeev Chopra, Director, LBSNAA, Shri V K Yadav, Chairman Railway Board, Indian Railways, Shri Alok Tewari, Additional Member, EnHM, Railway Board, Shri S.P.S Chauhan, DG, NAIR, Shri Nikhil Seth, Executive Director, UNITAR, Shri Atul Bagai Country Head, UNEP India Office and Ms. Anubha Prasad National Coordinator, PAGE UN Environment Country Office, India.

The training programme received an incredibly positive feedback from participants and master trainers alike. Participants rated the overall training programme at 8.8 out 10.
